Dear Chairman Murray, Chairman Ryan, Ranking Member Sessions, and Ranking Member Van Hollen:

Thank you for your commitment to resolving our nation's current budget challenges. As faithbased organizations, we ask that you protect life-saving humanitarian and poverty-focused development assistance in the budget negotiations you are conducting. Recognizing that the multi-year sequester must ultimately be replaced for the good of our nation, we urge you to do so in a way that does not further cut the International Affairs Budget, particularly accounts that support humanitarian and poverty-focused development assistance programs.

Since 2010, the base foreign aid budget has been reduced by 19 percent, limiting programs that not only empower the impoverished and marginalized, but also serve pragmatic American interests by promoting our own economic growth and national security. As people of faith we recognize especially that these programs promote the inviolable dignity of each human person, a powerful motivation that underlies all of our work and efforts throughout the world.

Efforts to combat global poverty and enhance human security over the past several decades have yielded impressive results. Child survival is a one example. As a result of US leadership with partners around the world, 6 million fewer children around the world will die this year than did in 1990. Compared to the year 2000, pneumonia will kill 625,000 fewer children this year; diarrhea 663,000 fewer; measles, 397,000; malaria, 228,000; and AIDS 107,000 fewer children.

The U.S. government has provided indispensable funding, influence and leadership to launch initiatives, strengthen local capacity, and coordinate humanitarian strategies across national boundaries. America's public contributions overseas deliver results the private sector cannot achieve alone. This poverty-focused development assistance is some of the most effective investments we fund, annually costing Americans per capita:

- \$1 to fund all U.S. government programs that provide access to safe water
- 50 cents to fund our efforts overseas to finally eradicate polio
- \$3 to fund our work to defeat malaria
- 30 cents to fund U.S. efforts to treat a collection of seven debilitating but preventable diseases that afflict one billion people.

As people of faith, we ask that you work with your colleagues on the Budget Conference Committee to continue to achieve these impressive bipartisan goals. Less than one percent of the budget, humanitarian assistance and poverty-focused development accounts are a small investment with enormous impact.
