Dear Chairman Leahy, Chairman Granger, Ranking Member Graham, and Ranking Member Lowey:

Thank you for your commitment and support of life-saving humanitarian and poverty-focused development assistance accounts through the International Affairs Budget.

As faith-based organizations concerned about the most vulnerable among us, we are very concerned about the significant humanitarian needs across the globe this year. We write to urge the House and Senate Appropriations Subcommittees on the Department of State, Foreign Operations, and Related Programs to robustly support funding for international humanitarian and poverty-focused development assistance. Such continued investments in life-saving programs will help to maintain past gains combatting global poverty and enhancing human security. These successes include a reduction in global hunger by 34% since 1990, an effort our nation has significantly supported through funding of various food assistance and agricultural development programs.

As you know, the UN recently released its largest global humanitarian appeal in history for \$13.5 billion. The complex Syrian conflict leaves 9.3 million Syrians in need and the entire region struggling to provide. Threatened by starvation at the start of a third harsh winter, U.S. leadership is needed now more than ever in this volatile region. And in places like the Central African Republic, new peacekeeping forces are critical to prevent an escalation of the conflict. These programs are a small investment to avoid costlier military or other interventions.
