Dear Chairpersons Mikulski and Rogers, Ranking Members Shelby and Lowey,

As communities of faith and faith-based organizations committed to advancing the dignity of all God's children, we would like to thank your Committees for supporting US leadership to combat poverty, hunger, and disease around the world.

In 2013 alone, US international health and development assistance programs have improved the lives of more than 135 million people worldwide. And, according to the Food and Agriculture Organization of the United Nations (FAO), the number of chronically undernourished people in the world's poorest countries has fallen by nearly 10% over the past two decades.

Yet, despite this remarkable and positive progress, one in four sub-Saharan Africans still face food shortages, and this situation appears especially dire in South Sudan, where the threat of famine increases daily. And, aside from food insecurity, other significant challenges remain, most evidenced by the worsening humanitarian and refugee crises in Syria, Iraq, and Ukraine to the growing Ebola epidemic in West Africa, which in many countries, have spiraled out of control due to weak and underdeveloped health care systems.

In this context, as your Committees finalize the FY2015 Agriculture and State-Foreign Operations Appropriations bills and/or draft another FY2015 Continuing Resolution/Omnibus, we urge you to provide the maximum level of funding possible for humanitarian and poverty-focused development assistance accounts. Many of these programs are funded through Development Assistance, USAID Global Health programs, International Disaster Assistance, Migration and Refugee Assistance, and Food for Peace accounts. As your partners in the faith community, we remain committed to further leveraging these U.S. investments in order to save lives, improve human health, promote economic prosperity, and advance environmental sustainability.

Our faith traditions affirm that nations and governments have an indispensable role in feeding the hungry, healing the sick, providing opportunities to the impoverished, and inspiring hope within our neighbors near and far. As committed partners, we look forward to further collaborating with you in these efforts.


