Dear Chairmen Hoeven and Aderholt, and Ranking Members Merkley and Bishop,

As members of the Interfaith Working Group on Foreign Assistance, a network of over 50 faith-based organizations advocating for the world's most vulnerable people, we would like to thank you for your continued support in robustly funding life-saving education, child development, food assistance, and security programs within the Agricultural appropriations bill. Our community is committed to empowering those suffering from extreme poverty, hunger, and food insecurity around the world, which is why we appreciate both the sustained and increased funding levels to these accounts within the International Affairs and Foreign Agricultural Service budgets. Thanks to your committee's efforts, the U.S. government has made impressive strides in combating global hunger and malnutrition. Just last year alone, international food assistance made an extraordinary impact for 49 million people in 61 countries worldwide.

Despite the significant progress that has been made, world hunger driven by violent conflict and climate-related shocks is on the rise. Today, 815 million men, women, and children go to bed hungry, and lack nutritious food necessary to live. Additionally, 124 million people in 51 countries face crisis-level food insecurity or worse, which requires urgent humanitarian action to save lives, protect livelihoods, and reduce hunger and malnutrition. After steadily declining for over a decade, food needs of extremely vulnerable communities are increasing.

As your committees look towards conference negotiations for fiscal year 2019, we urge you to provide the maximum level of funding possible for these vital programs that work to alleviate suffering for people living in extreme poverty and food insecurity. Specifically, we ask that you provide no less than:

- **\$1.7 billion for Food for Peace, as proposed by the Senate**
- **\$210.25 million for McGovern-Dole, as proposed by the Senate**
