CCIH seeks a short term consultant to identify and assess faith-based organizations/health facilities in two regions of South Sudan (Ibba County (Ibba Center, Manikara, and Madebe), and Maridi County (Maridi Center, Mboroko, and Nagbaka)) for a USAID-funded project. Local organizations may be eligible for a project addressing maternal and child health and family planning.

Duration of Consultancy: Completed within 2 months of the start date. Payment terms: Fixed Price

# DELIVERABLES

- A check-list of indicators (to be approved by CCIH and partners) to assess faith-based organizations/faith-based health facilities in two regions of South Sudan as possible partners in a MNCH/FP project, identifying strengths and weaknesses of the organization generally and as they relate to ability to execute the specified project.
- Brief Reports on meetings with South Sudan FBOs/HFs.
- Analysis and final report completed within 2 months of the start date (includes one round of edits) including:
  - A list of up to 20 faith-based organizations (FBOs)/faith-based health facilities (HFs) in two specified regions of South Sudan that could work on this project in priority order.
  - Recommendations about 1) Which organizations should be at the top and why, and 2) process and thoughts about structuring a response.
- Contribute to a CCIH staff-developed strategy for working with these organizations/facilities in South Sudan.
- Weekly status updates to CCIH staff via email and virtual calls.

# WORK CONDITIONS

- Consultant is completely independent of CCIH and will not be provided with benefits, office or supportive services beyond what is outlined in the agreement.
- Consultant will work independently but maintain close contact via phone and online with CCIH staff.
- International travel to South Sudan 1 trip, less than 7 days. CCIH will provide a risk/safety assessment
  and recommend best practices for safe travel and accommodation. The consultant is responsible for
  booking his/her own flight, transportation to/from airports and within the country, scheduling his/her
  appointments, arranging accommodation and meals, applying and paying for visa, etc. CCIH will assist
  with contacts where possible.
