CCIH seeks a consultant to supervise and ensure compliance of a USAID-funded project with two local organizations in South Sudan (Maridi County - Maridi Center) for a USAID-funded project.

Duration of Consultancy: January 2021 - January 2023; 10-15 hours/week Payment terms: Fixed Price

DELIVERABLES

- Assist CCIH in finalizing sub-agreements with local organizations to ensure they can meet the reporting requirements for a USAID funded project.
- Assist local organizations in implementing traditional trainings (FP, iCCM, and pregnancy related emergency danger signs and responses) for community health workers in the geographic target areas; monitoring community health workers, ensuring monthly evaluations are conducted and reported, participate in reflect and learn activities, etc.
- Assist CCIH POC on comprehensive organization capacity assessments (C-OCA), identifying strengths and weaknesses of the organization generally and as they relate to ability to execute the specified project, and assisting them with creating action plans for improvement and helping them execute such action plans.
- Serve as main liaison between local organizations and CCIH staff.
- Bi-weekly status updates to CCIH staff via email and monthly virtual calls with brief reports on meetings with South Sudan FBOs.
- Quarterly written reports for the donor.
- Consulting with the World Relief South Sudan team in-country; attending consortium meetings that may include WR SS, the local partners, government officials, health facility staff, etc.

WORK CONDITIONS

- Consultant is completely independent of CCIH and will not be provided with benefits, office or supportive services beyond what is outlined in the agreement.
- Consultant will work independently but maintain close contact via phone and online with CCIH staff.
- Consultant must be based in South Sudan.
- Travel within South Sudan to Maridi County. The consultant is responsible for booking his/her own flight, transportation to/from airports and within the counties scheduling his/her appointments, arranging accommodation and meals, etc.

- Excellent English written and oral communication skills and ability to speak in the local language.
